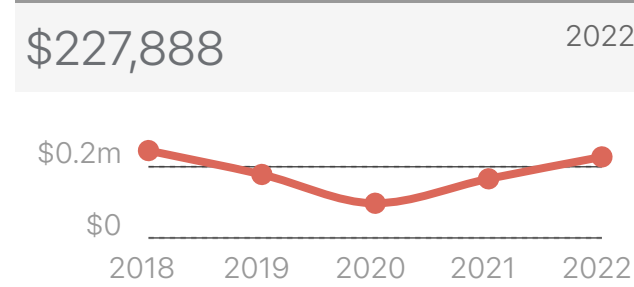

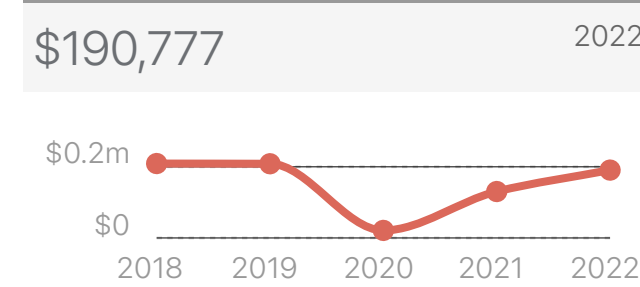
Description

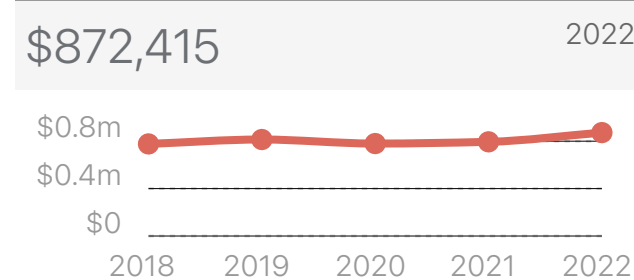
Total revenues



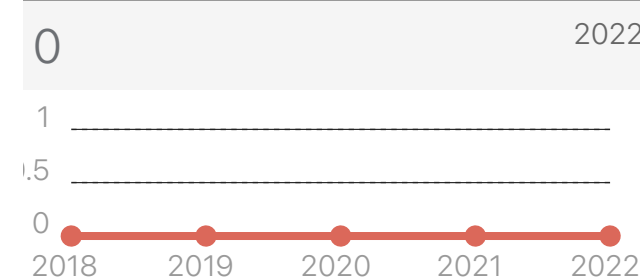
Total expenses
